TRANSPORTATION PERMITS

(SECTION 94 A.B.C. LAW)

This application must be filed with the State Liquor Authority office that supports the county where you will establish your business. See attached schedule.

A permit may be issued for any of the following types of activities. Please read the description of the permits and their conditions **carefully**.

TRUCKING - **Complete application and signature sheet:** Authorizes the permittee to transport alcoholic beverages within this State; to transport alcoholic beverages from within the State to points outside the state; to transport alcoholic beverages from outside the State to points within the State.

This application must be filed with the State Liquor Authority at Albany, Buffalo or New York City, whichever is nearest to the place of business of the applicant, and must be accompanied by the following:

The fee is pro-rated based on the date of issuance. (\$173.00) The license period is three (3) years. Submit a check or draft for the required fee made payable to the order of the State Liquor Authority.

The following is required with the completed application:

Required bond (\$1,000.00) issued by any qualified surety company authorized to execute such bonds in the State of New York, unless the applicant holds a trucking permit for the period applied for and has filed a bond with the Authority in support of such permit.

FLEET TRUCKING PERMIT - **Complete application and signature sheet:** Authorizes the permittee to transport alcoholic beverages in any and all vehicles owned or hired, and operated by such permittee within this State; to transport alcoholic beverages from within the State to points outside the State; to transport alcoholic beverages from outside the State to points within the State. A Fleet Permit allows the licensee to register all vehicles under a blanket permit without having to provide detailed information on each vehicle and allow adding and removing of vehicles without notification to the Liquor Authority.

- CHECK or DRAFT for **\$6,420.00 if application is submitted on or after January 1 and \$3,220.00 if submitted after July 1**, payable to the order of the State Liquor Authority.
- REQUIRED BOND (\$1,000.00) issued by any qualified surety company authorized to execute such bonds in the State of New York, unless the applicant holds a trucking permit for the period applied for and has filed a bond with the Authority in support of such permit.
